### **Y10 INTO Y11 CÔTE D'AZUR TRIP - 17<sup>th</sup>- 21<sup>st</sup> OCTOBER 2022**

Your child has shown interest in taking part in a forthcoming residential trip to Nice. It will be a 4-night stay in half board accommodation in central Nice, which offers excellent access to the various attractions we plan to visit. It will be a busy time with the emphasis on pupils using their French as much as possible. Your child will have the opportunity to enhance their studies by touring the city, building on work covered in school and learning more about French culture. The proposed dates for this trip would be from Monday 17 October to Friday 21 October 2022.

I shall write to you again with more precise details of travel arrangements and our itinerary in the region in due course.

The total cost of the trip is £650.00. This includes travel, breakfast, evening meals and entrance tickets to museums and historic buildings. Students will need some pocket money for extras. Unfortunately, school grants are not available for such trips.

To secure your child a place, please complete the attached form and return it to the Languages office. You will also need to pay a £250.00 non-refundable deposit into Bromcom/MCAS. The two remaining instalments of £200.00 and £200.00 each will be due on 13 August 2022 and 13 September 2022 respectively. You can, if you prefer, pay the full amount in a single instalment.


Please note that in order to travel your child will need to have a valid individual passport (valid at least six months after our return), evidence of two doses of the Covid-19 vaccine as well as a GHIC card. The passport and GHIC card can be obtained via your local post office and the verification of the Covid vaccinations can be obtained from NHS England. You can also apply for the GHIC card online at [www.ghic.org.uk](http://www.ghic.org.uk), which can be much faster than using the Post Office. Please ensure you apply for all necessary documents well ahead of time. Please be aware that all pupils' passports will be collected one week in advance of the journey in order to minimise potential inconvenience on the day.

**Please pay through Bromcom/MCAS and return a completed reply slip with a photocopy of your child's passport, GHIC card and verification of the Covid vaccinations to the Languages Office by Wednesday 13 July 2022 at the latest.**

If your child is not in possession of a British passport, please contact us as soon as possible in order to discuss how best to obtain the necessary travel documents.
